ORDINANCE NO. 9348-2004

AN ORDINANCE REVERTING THE SUM OF ₱450,000.00 FROM THE "SPECIAL PROJECT: POVERTY REDUCTION EFFORT FOR CAGAYAN DE ORO RESETTLEMENT AREAS" IN THE 2004 ANNUAL BUDGET OF THE CITY PLANNING AND DEVELOPMENT OFFICE, AND REAPPROPRIATING THE SAME TO BE MADE AVAILABLE FOR THE PAYMENT OF HONORARIUM AND OTHER EXPENSES FOR ACADEMIC RESEARCH OF THE CITY, PER MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE CITY AND THE ARCHAEOLOGICAL STUDIES PROGRAM, UNIVERSITY OF THE PHILIPPINES AS AUTHORIZED UNDER ORDINANCE NO. 9053-2004

BE IT ORDAINED by the City Council (*Sangguniang Panlungsod*) of the City of Cagayan de Oro in session assembled that:

SECTION 1. - The sum of ₱450,000.00 is hereby reverted from the item "Special Project: Poverty Reduction Effort for Cagayan de Oro Resettlement Areas" in the 2004 Annual Budget of the City Planning and Development Office, and the same is hereby reappropriated to be made available for the payment of honorarium and other expenses for academic research of the city, per Memorandum of Agreement entered into by and between the City and the Archaeological Studies Program, University of the Philippines as authorized under Ordinance No. 9053-2004.

SECTION 2. - This Ordinance shall take effect upon its approval.
